



Ohio Region III Rescue Strike Team



Thank you for your interest in the Ohio Region III Rescue Strike Team. This strike team serves as the structural collapse rescue response for an 8 County Region in West Central Ohio. Members respond to structural collapse and trench rescue incidents with the Region 3 Strike Rig that carries a large compliment of Technical Search and Rescue equipment. In addition, we have structural collapse and trench trailers strategically located throughout the region. This is a specialized technical rescue team and previous rescue experience is necessary.

The Strike Team selection process will consist of a detailed review of the attached application and supporting documents. Applicants may also be subject to an interview and drug screening as well as a background check. Selection will be based upon your experience and qualifications, as well as the current needs and requirements of the Strike Team. Once a selection is made, Strike Team members will be cross-trained in all areas of search and rescue. This flexibility is an integral part of the team's success.

Applicants must understand that upon selection, they will be required to attend training sessions, simulated deployments, and occasional work details to maintain an active status with the Strike Team. Members who fail to maintain an active status within the team may be subject to removal. Additionally, all applicants must remain "fit for duty" with their home department

Applicants must be employed by a public government entity within the 8 county response area or have specialized training in lieu of employment requirement. Applicants must hold a valid Ohio Driver's license and proof of insurance. Each application must be signed by the Chief of the applicant's department or the applicant's work supervisor if not emergency service affiliated, before it will be accepted.

The Region III Rescue Strike Team is not responsible for miscommunication due to inaccurate or missing information that was not submitted according to procedure. The attached application must be completed in its entirety and submitted, preferably electronically. Areas that do not pertain to the applicant should be marked "N/A". All documents submitted become the property of the Region III Rescue Strike Team.

EMPLOYER MEMORANDUM OF UNDERSTANDING

Your employee is making application to the Ohio Region III Rescue Strike Team. Ohio Region III Rescue Strike Team is an effort of Miami Valley Fire / EMS Alliance and operates under the tenants of our mutual aid agreement. As a part of this application process, each applicant must secure the written approval of his/her primary employer. The Executive Committee of the Region 3 Strike Team strongly believes that each employer approving an employee for appointment to the Ohio Region III Rescue Strike Team should completely understand the needs of the Ohio Region III Rescue Strike Team and those restraints that could, in time of emergency or disaster, present themselves to you as his/her employer.

As a prospective Ohio Region III Rescue Strike Team Member, each applicant is making a serious commitment to provide specialized skills, training and expertise to the citizens of our area; the primary purpose for the formation of the Ohio Region III Rescue Strike Team. In turn, as an employer supporting this appointment to the Ohio Region III Rescue Strike Team, you are also making a strong commitment to our community. As in other cooperative efforts under mutual aid, our members remain your employees in training and in response. Compensation issues remain yours, but for purposes of Ohio Region III Rescue Strike Team training and on/off duty response you agree to provide worker's compensation protection for your member-employee.

Any response to Ohio Region III Rescue Strike Team activation by your employees remains at your discretion. As a special response entity, the value of the Ohio Region III Rescue Strike Team can only be realized by participation and allowing members to respond when requested, whenever possible. Realistically, the Ohio Region III Rescue Strike Team cannot expect every member to be available for every emergency or disaster. In addition, not every emergency will dictate the need for the entire Ohio Region III Rescue Strike Team. There will be incidents where only a partial contingent of the Ohio Region III Rescue Strike Team will be deployed. However, as an approving employer, you are stating that in times of need, emergency and/or disaster, you are willing, when feasible, to relinquish this employee from his/her normal duties (and permit off-duty response) to fill a specialized spot with the Ohio Region III Rescue Strike Team.
